156336	PSR	Modified PSR to correct the exception error that some schools reported receiving when generating PSRs for a selected group of students.	
156336	GDE	Updated the "Student Period Absences" extract to remove the duplicate "School Number" column.	
156336	Learning Plan (Education Plans)	 Added the ability to create: Student Learning Plans. Student Behavior/Safety Plans. Proficiency Plans. These new plans can be accessed from <i>Student > Ed. Plans</i>. Use the dictionary to select <i>Plan Definition > Options > Add</i>. 	
157072	Diploma Verification Report	 Modified to display the completion date for course in progress (courses from Student schedule). Corrected the exception error that occurred for students with blank school course code on student transcript details. 	
154237	Configuration	Previously not all Diploma Categories were fully populated with all possible courses from all years and all Graduation Programs. Now, all Graduation Program Diploma Categories contain all courses necessary for graduation. This affected the Graduation Progress screen.

Modified IEP Workflow to display student name in the breadcrumbs. Modified IEP Report to display the support team members. Designation alert now displaying generic message. Student grade displaying on IEP report.
156404	BC Credit Calculation Procedure	This procedure is run from the School view > Grades top tab > Transcripts side tab. It updates credits based on course final marks or, if available, blended marks. Previously, this procedure only calculated credit based on final marks. This fix now also calculates credit based on the blended mark.

Our investigation confirmed that the records were connected to the correct school but the wrong district. A fix was implemented to correct this by matching the school to the correct District.
